One Minutes (10 per side)

Members are advised that the House is expected to recess immediately following One Minutes. At 11:45 a.m. a Congressional Remembrance Ceremony honoring the anniversary of September 11, 2001 will take place on the West Capitol Steps.

Suspensions (2 bills):

- 1) **H.Res. 1420** - Recognizing September 11 as a day of remembrance, extending sympathies to those who lost their lives on September 11, 2001, and their families, honoring the heroic actions of our nation's first responders and Armed Forces, and reaffirming the commitment to defending the people of the United States against any and all future challenges (*Sponsored by Reps. Hoyer / Boehner*)
- 2) **H.R.6532** - To amend the Internal Revenue Code of 1986 to restore the Highway Trust Fund balance (*Sponsored by Rep. Rangel / Ways and Means Committee*)

Postponed Suspension Votes (6 Bills):

- 1) **H.R. 6169** - To designate the facility of the United States Postal Service located at 15455 Manchester Road in Ballwin, Missouri, as the "Specialist Peter J. Navarro Post Office Building" (*Sponsored by Rep. Akin / Oversight and Government Reform Committee*)
- 2) **H.R. 6513** - Securities Act of 2008 (*Sponsored by Rep. Kanjorski / Financial Services Committee*)
- 3) **H.Res. 1207** - Directing the Chief Administrative Officer of the House of Representatives to provide individuals whose pay is disbursed by the Chief Administrative Officer by electronic funds transfer with the option of receiving receipts of pay and withholdings electronically (*Sponsored by Rep. Foxx / House Administration Committee*)
- 4) **H.R. 6608** - House Reservists Pay Adjustment Act of 2008 (*Sponsored by Rep. Brady (PA) / House Administration Committee*)
- 5) **H.R. 6475** - Daniel Webster Congressional Clerkship Act of 2008 (*Sponsored by Rep. Lofgren / House Administration Committee*)
- 6) **H.R. 6832** - Veterans' Construction and Extensions Act of 2008 (*Sponsored by Rep. Filner / Veterans' Affairs Committee*)
